



Terms & Conditions

By accessing or using this website (the "Site"), which is hosted by HMI INC, and located at 57 Providence Highway, Norwood, MA 02062 ("HMI") and sponsored by Mars Supply, ("Company", "us", "our", and "we").", collectively ("we" or "us"), you acknowledge that you have read, understood and agree to be legally bound by these terms and conditions, including without limitation the terms and conditions set forth below, (collectively, the "Terms"); agree to comply with all applicable laws and regulations; and represent and warrant that you are at least 18 years of age and have obtained any and all permissions necessary to enter into and to be bound by these Terms. Program Eligibility

Points

Miscellaneous
